This ingredient is packed in two-ply laminated paper bags weighing 50lbs net each. No metal fasteners or closures of any kind are used. Bags are shipped palletized

CODING

All bags are identified with a lot or batch code. Each bag is properly identified to include the manufacturer name, ingredient name, production date or lot code and net weight.

SHIPPING AND STORAGE

The product is shipped and stored in a cool, dry environment, protected from moisture and foreign odors. Our warehouse is free of pests and has an appropriate pest control management program in place. Shipping and storage temperatures range from 60 to 70°F and 40 to 50% relative humidity.

All delivery vehicles are cleaned, undamaged and free from strong odors, insect, and rodent contamination. All trailers carrying a full load of product are sealed with a numbered seal. The number from the seal shall be recorded on the bill of lading. Product shipped on trailers containing less than truck load (LTL) quantities are not accompanied by any substance of a poisonous, hazardous, or potentially deleterious nature.

The product is shipped on standard 40 X 48 food grade wood pallets.
